To: All Supplier Member Attendees at the November 4-7, 2009 NICRA 76th Annual Meeting

Enclosed is the registration form for NICRA's 76th Annual Meeting in Scottsdale, Arizona, November 4-7, 2009. Each exhibitor must take either one Package A or one Package B registration package. Additional personnel in the booth should register under A La Carte Functions, Supplier Room Only (\$145) plus any meals or optional activities (additional fees required).

This year we are requiring that everyone (including children) who attends the Annual Meeting and Convention register and pay a registration fee. Trading badges is strictly prohibited. **This is for your own safety and protection.** No one will be admitted to the exhibit hall, seminars, meals, or optional activities without a badge. **Deadline for advance registration is October 19, 2009, after that date you will have to register on-site.**

Spouses and/or significant others and children who will not be attending seminars, but who will be attending meals, the Ice Cream Clinic, Best Coffee Flavor and Your Best New Flavor Contests, coffee breaks, and the Bryce Thomson Scholarship Auction must register under "A La Carte Functions" - Supplier Room.
